### 2020 TRADITIONAL NURSING APPLICATION PROCEDURE

#### Application Procedure

For consideration into the MSC Nursing Program applicants must have a completed application on file in the Health Science Building, Office Suite 100, received on or before noon (12 pm) Wednesday, March 11, 2020. Incomplete applications will not be considered for acceptance. Applicants are strongly encouraged to hand deliver their applications to the MSC Tishomingo Campus. However, any applicant mailing their application should use a method that provides a return receipt for evidence of delivery.

#### All applicants must meet the basic requirements listed below.

1. Have a completed application on file by posted deadline
2. Achieved a minimum ATI TEAS admission assessment exam score of 58.7%
3. Achieved a minimum ACT composite score of 19 or college GPA of 3.0 or higher if composite ACT is less than 19
4. Have a College Retention GPA of 2.5 or nursing prerequisite GPA of 3.0

#### Completed applications should contain the following:

1. Nursing Application with current student picture attached to page 3
2. Official transcripts from high school, GED certification, Technology Centers, and/or Colleges and Universities
3. Results of background check from Castle Branch completed February 1<sup>st</sup> through March 11, 2020. Results must be available by noon on March 11, 2020.
4. All documents submitted together in a single large envelope

**Note:** Castle Branch provides an extensive nationwide background report which includes, but is not limited to, Oklahoma State Bureau of Investigation (OSBI) background searches for sex offender, violent offender, and criminal history. Background checks are required by all clinical agencies for students who utilize their facilities to satisfy the clinical component of the nursing curriculum.

All students will be required to pass randomly administered drug tests.

Applicants for Oklahoma licensure as a Registered Nurse must meet all state and federal requirements. Questions regarding these requirements should be directed to the nursing program, (580)-387-7420. Applicants may also obtain information on the Oklahoma Board of Nursing website, [www.ok.gov/nursing](http://www.ok.gov/nursing).

## SELECTION PROCEDURE

1. Only completed applications containing all required criteria and received by the posted deadline will be considered for acceptance.
2. Acceptance into the MSC Nursing program is competitive. Applicants will be awarded points and ranked according to the admission points system. The Nursing Selection Committee will make the final determination regarding applicant ranking and total selection point calculations. Priority for acceptance is based on the applicants rank.
3. Applicants having identical selection point totals will be ranked according individual GPA, ACT and Science course grades.
4. Applicants selected for admission will be notified via the email address listed on the nursing application.
5. Qualified applicants who have not been selected for admission into the fall class may be placed on an alternate list.

**Note:** Applicants who disagree with either the ranking or total selection point calculations may schedule an appointment with the Nursing Program Chair. Applicants to the Murray State College Nursing Program are selected in accordance with nondiscriminatory practices.
